TRAINING PROGRAMME FOR THE TEACHERS AS COUNSELLORS

Under NALSA (Legal Services to the Mentally ILL and Mentally Disabled Persons) Scheme, 2015, the Sikkim State Legal Services Authority as per the directions of Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA organized a Training Programme for the Teachers identified as Counsellors to address Student's Mental Health Issues and to provide Counselling to the Students and their Parents on 29th July, 2023 at Chintan Bhawan, Gangtok.

During the programme, Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA informed the participants that the training programme was a result of a meeting which was conducted with the Psychiatrists and Psychologists of STNM Multispecialty Hospital, Sochakgang to initiate discussions on measures to be adopted on mental health issues to address the alarming rate of suicides in Sikkim, wherein, it was learnt that at present, only few schools are having trained School Counsellors for addressing the mental health issues of students and counselling them along with their guardians.

At the outset, Hon'ble the Chief Justice, High Court of Sikkim and Patronin-Chief, Sikkim SLSA welcomed all participants present in the meeting. His Lordship reiterated that during the inauguration of the Drug De-Addiction-cum-Rehabilitation Centre at Kitchudumra, Namchi District which was held on 12th August, 2022, it was found that the State Government has spent Rs. 17,53,00,000/- (Rupees seventeen crore fifty-three lakhs) only from the State exchequer for the construction of the Centre and the same is lying underutilized till date. Further, he opined that there is a dire need to make it functional.

The following resolutions were passed during the meeting:

- 1. The Chief Secretary, Government of Sikkim/NGO shall initiate an action for construction of a State Level Trust.
- 2. The Trust Deed shall be drafte-d by the Registrar General, High Court of Sikkim/Secretary, Law Department within one month.
- 3. Trust Deed shall also include SOP for manpower management viz; Doctors/Psychiatrist/Clinical Psychologists etc. for the Centre, monitoring committee at the State Level and District Level.

TRAINING PROGRAMME FOR PARA-LEGAL VOLUNTEERS, COUNSELLORS, ASHA AND ANGANWADI WORKERS

Under NALSA (Legal Services for Differently Abled Children) Scheme, 2021, a training programme for Para-Legal Volunteers, Counsellors, Accredited Social Health Activists (ASHA) and Anganwadi Workers was organized by Sikkim SLSA on 30th August, 2023 at Sikkim Judicial Academy, Sokeythang for identification of children with Autism Spectrum Disorder and other mental illnesses in schools and villages by domain experts.

Ms. Subarna Rai, Ld. Member Secretary, Sikkim SLSA in her welcome address informed that children from vulnerable sections of our society and conditions of children with intellectual disabilities is very deplorable. There is an urgent need for identification of such children in the rural areas to help them avail required medical assistance and therapy. It was informed that the programme was organized under the directions of Hon'ble Executive Chairperson, Sikkim SLSA for the Para-Legal Volunteers, Counsellors, Health Educators and ASHA workers deputed by the Health & Family Welfare Department and Anganwadi Workers of all the districts who work at the grassroot level and have accessibility to such children who are denied their basic rights due to stigmatization and lack of awareness. They were urged to identify and intimate Sikkim SLSA regarding such children so that necessary assistance can be rendered to them.

The Resource Persons for the said programme were Dr. Bibushan Dahal, Senior Consultant Psychiatrist ad Ms. Archana Chettri, Clinical Psychologist, Department of Psychiatry, STNM Hospital, Health & Family Welfare Department.

Dr. Bibushan Dahal, Senior Consultant Psychiatrist apprised the gathering on mental health issues. He gave a brief history on mental illness and informed that mental health is a state of well being which enables a person to cope with stress, realize ones abilities, learn and work well and contribute to their community. The cycle of mental health and the determinants of mental health namely biosocial factors, substance abuse, unfavourable circumstances, early childhood migration and traumatic events were also deliberated upon by him.

Ms. Archana Chettri, Clinical Psychologist, explained child and adolescent mental disorders and other form of intellectual disorders as well as the signs and symptoms which can assist the participants to identify children with such disorders. She also apprised on behavioral disorders such as Attention Deficit Hyperactivity Disorder (ADHD), Oppositional Defiant Disorder (ODD) and Conduct Disorder (CD) and urged the participants to sent children showing any of the symptoms to the hospital for screening and early detection of the disability so that timely intervention and treatment can be rendered.

The programme was followed by an interactive session between the participants and the Resource Persons and numerous queries raised were addressed by the Resource Persons.

The programme was attended by Officers of the Health & Family Welfare Department, Para-Legal Volunteers of Sikkim SLSA, Counsellors posted in the Primary Health Centres, Health Educators, ASHA and Anganwadi Workers.

Qualified Mediators Mr. Laxmikant Gaur and Mr. Dharmender Rana from Delhi imparted 20 hours Refresher Course on Mediation to 12 trained Advocate Mediators which was observed by Mr. Manmohan Sharma, Senior Judge Trainer from Delhi.

The training included lectures, facilitation, role plays, coaching and intense interaction with the participants on various subjects on mediation such as conflict management, ADR mechanism, relevance of section 89CPC, concept, process and various techniques and benefits of mediation. The curriculum of training programme emphasized the importance of practical experience in becoming an effective mediator. During frequent role plays, each participant actively mediated variety of disputes with expert feedback. The programme was designed to provide individuals with the knowledge and skills necessary to mediate a variety of everyday disputes which come before subordinate Courts.

MISSION MODE CAMPAIGN FOR PREVENTION AND ERADICATION OF TUBERCULOSIS

Sikkim SLSA under the direction of Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA and under NALSA (Legal Services to the Mentally ILL and Mentally Disabled Persons) Scheme, 2015 organized a Mission Mode Campaign for Prevention & Eradication of Tuberculosis in all Educational Institutions in Sikkim in collaboration with the State Tuberculosis Cell, Health & Family Welfare Department from 14th August, 2019.

The awareness drive aimed at generating awareness on prevention and eradication on Tuberculosis/Multi-drug resistant tuberculosis (MDR/TB)/Extensively drug resistant tuberculosis (XDR-TB) for the students of all the educational institutions in Sikkim.

The Mission Mode Campaign was organized on 15th September, 2023 at ICFAI University, Sichey, Gangtok.

Resource Person, Dr. Rohini Tamang, Medical Officer TB Control, District TB Centre, Gangtok apprised the participants regarding tuberculosis its signs, symptoms and treatment, Drug-Resistant TB, Multi Drug Resistant and Diagnosis of TB.

Resource Person, Mr. Dinesh Shanker, Health Educator emphasized the participants on health, mental wellness, good and poor mental health, various

types of mental disorder, signs of autism, warning signs of suicide and how to prevent it.

During the programme, Active Case Finding was conducted by the Resource Persons. A total of 161 participants (159 students and 02 Faculty Members) participated in the above programme.



MENTAL HEALTH CAMP
