

**MESSAGE ON “MEDIATION FOR THE NATION” CAMPAIGN
(90 DAYS’ MEDIATION DRIVE TO SETTLE/RESOLVE PENDING CASES
ACROSS TALUKA COURTS, DISTRICT COURTS AND HIGH COURTS OF
INDIA)**

The **National Legal Services Authority (NALSA)** in collaboration with the **Mediation and Conciliation Project Committee (MCPC)** of the Supreme Court of India has launched a special initiative titled ‘**Mediation For the Nation**’. This initiative guided by **Hon’ble Mr Justice B R Gavai, the Chief Justice of India & Patron-in-Chief, NALSA** and **Hon’ble Mr Justice Surya Kant, Judge, Supreme Court of India & Executive Chairman, NALSA** and **Chairman, MCPC**, aims to promote resolution of pending legal matters through **Mediation**.

The 90 days’ campaign, commencing on 1st of July, 2025 will be conducted across the length and breadth of the country. It is a focused effort to facilitate settlement of pending cases in Taluka Courts, District Courts and High Courts through the process of mediation.

All cases that have the potential for amicable resolution may be considered suitable for referral to mediation. Categories of such cases include:

ACCIDENT CLAIMS CASES,
DOMESTIC VIOLENCE CASES,
CHEQUE BOUNCE CASES,
COMMERCIAL DISPUTES CASES,
SERVICE MATTERS CASES,
CRIMINAL COMPOUNDABLE CASES,
CONSUMER DISPUTES CASES,
DEBT RECOVERY CASES,
PARTITION CASES,
EVICTION CASES,
LAND ACQUISITION CASES,
OTHER SUITABLE CASES.
