SIX DAYS TRAINING PROGRAMME FOR CONVICT PARA-LEGAL VOLUNTEERS

Pursuant to NALSA's Scheme for Para-Legal Volunteers (revised) & Module for the Orientation-Induction-Refresher Courses for PLV Training and under the directions of Hon'ble Executive Chairperson, Sikkim State Legal Services Authority, six days training programme for Convict Para-Legal Volunteers was organized by Sikkim SLSA for the convicts lodged at State Central Prison, Rongyek, Gangtok from 21st to 26th April, 2025 at the jail premises of State Central Prison Rongyek.

Mr Kazi Sangay Thupden, Pro-Bono Lawyer, Sikkim SLSA was the Resource Person for the said programme.

During the course of the training, many aspects, core purposes and the multifaceted responsibilities of a Para-Legal Volunteer on various legal subjects was explained to the Convicts at great length providing them with a clear understanding as to how they can effectively assist fellow inmates.

Topics deliberated, discussed and educated on were critical aspects of the Juvenile Justice Act, 2015, property laws, Labour laws, critical aspects of legal framework concerning youth individuals, Equal Remuneration Act, 1976 and free legal aid.

Two Convict PLVs namely Sanjit Rai (Class X passed) and Vishan Gurung (Diploma in Hotel Management) who are serving long term sentences were trained during the programme.

The meeting was chaired by the Hon'ble Executive Chairperson wherein the Member Secretary, Sikkim SLSA, welcomed the Hon'ble Executive Chairperson, Sikkim SLSA and the stakeholders apprising about the agenda of the meeting.

The Hon'ble Executive Chairperson convened the meeting to seek opinions of the members who were present regarding premarital counseling, prior to registration of marriages. This point was mooted considering the increased number of divorces in Sikkim and the young adults enter the bond of marriage sans an understanding of the vast responsibility that come along with the marriage. This includes financial, societal, family, etc, responsibilities for which they appear to be totally unaware.

It was informed by Her Ladyship that the Hon'ble Supreme Court of India vide its judgment dated 14/02/2006, had directed the State Governments and the Central Government that, marriages of all persons who are citizens of India belong to various religious denomination should be made compulsorily registerable in their respective States, where such marriages are solemnized. Also, Her Ladyship informed about the provisions of the Hindu Marriage Act, 1955.

MEETING OF THE HIGH - POWERED COMMITTEE

Pursuant to the directions contained in the judgment dated 23/03/2020 passed by the Hon'ble Supreme Court of India, a High Powered Committee was to be constituted (i) to determine which class of prisoners can be released on parole or an interim bail for such period as may be thought appropriate, (ii) to take measures for protection of health and welfare of the prisoners to restrict the transmission of COVID-19 and (iii) sanitization and cleanliness exercise of prison campus and wards to ensure that the spread of the corona virus within the prison is controlled.

Accordingly, a High Powered Committee was constituted by the Home Department, Government of Sikkim comprising of (i) Hon'ble Executive Chairperson, Sikkim SLSA as a Chairperson, (ii) Principal Secretary, Home Department as a Member, (iii) Deputy Inspector General of Police (Prison), State Central Prison, Rongyek as a Member, (iv) Head of the District Prison, Namchi, South Sikkim as a Member and (v) Joint Secretary or above level officer, Home Department as a Member Secretary. Since then, meetings have been held, every quarter.

During this quarter, meeting of the High-Powered Committee under the chairmanship of Hon'ble Executive Chairperson, Sikkim SLSA/Chairman, High Powered Committee was held on 29th April, 2025 via virtual mode.

The meeting was attended by Mr M Bharani Kumar, IAS, Secretary, Home Department, Government of Sikkim/Member, High Powered Committee, Mrs Samita Sharma, Member Secretary, Sikkim SLSA, Mr Sharab Tonyot, Deputy Inspector General of Police (Prison), State Central Prison, Rongyek/ Member, High Powered Committee, Mr Khem Bhattarai, Additional Secretary (Confidential), Home Department /Member Secretary, High Powered Committee, and Mr Tseten Palzor Bhutia, Additional Superintendent of Police, District Prison, Boomtar, Namchi/Member, High Powered Committee.

DECONGESTION OF JAILS. Agenda Item No 2:

To consider Convicts who have undergone their (a) sentence or are entitled remission/suspension/commutation of sentence under Sections 432 and 432A of the Code of Criminal Procedure, 1973 (for short, "Cr P C") / 473 of the Bharatiya Nagarik Suraksha Sanhita, 2023, (for short, "B N S S") and Furlough in terms of the Sikkim Prison

Manual.

- (b) To consider UTPs released on Bail by the Court, but unable to furnish sureties;
- consider release of UTPs booked under (c) compoundable offences;
- To consider release of UTPs covered under Sections (d) 436 and 436A of the Cr P C/Sections 478 and 479 of the BNSS:

107, 108, 109, 151 of the Cr P C/Sections 126, 127, 128

and 170 of BNSS.

SENSITIZATION PROGRAMME ON SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013

In pursuance to the directions of the Hon'ble Supreme Court of India in its Order dated 12th May, 2023 passed in Civil Appeal No 2482 of 2014 titled Aureliano Fernandes v State of Goa and Ors and under the directions of Hon'ble Mrs Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA, the Sikkim State Legal Services Authority organized a Sensitization Programme on Sexual Harassment of Women at Workplace (Prevention, Prohibition & Redressal) Act, 2013 for female employees and Members of Internal Complaints Committee of the Law & Parliamentary Affairs Department, Government of Sikkim, on 17th May, 2025 at the Conference Hall of Sikkim SLSA, Development Area, Gangtok.

Trained Panel Advocates Mr Sushant Subba, Mr Hem Lall Manger and Mr Passang Tshering Bhutia were the Resource Persons.

The topics discussed/covered were Background and Role of Internal Committee - Prevention, Prohibition and Redressal, Definition of Sexual Harassment, Procedures and Process for Redressal and Case Study Analysis.

During the course of the programme, a short movie titled "Ab Khamosh Kyun" produced by Human Rights Law Network, New Delhi was also screened.

The Member Secretary, Sikkim SLSA delivered the welcome address while the vote of thanks was proposed by the Deputy Secretary, Sikkim SLSA.

A meeting chaired by the Hon'ble Mrs Justice Meenakshi Madan Rai, Judge, High Court of Sikkim & Executive Chairperson, Sikkim SLSA was held at the Conference Hall, Office of Sikkim SLSA, Gangtok on 6th June, 2025 (Friday) with the Remand Advocates of all the Districts viz; Gangtok, Mangan, Namchi, Gyalshing, Pakyong and Soreng and the Juvenile Justice Boards in order to ensure that the Remand Advocates are effectively fulfilling their responsibilities in carrying out their duties as per the model scheme of Legal Aid Counsels, in the Courts as per the directions passed by the Hon'ble Supreme Court of India in Criminal Appeal No 1277/2014 (Special Leave Petition (Crl) No 9127 of 2013) Arnesh Kumar Vs State of Bihar & Anr.

The Member Secretary, Sikkim SLSA welcomed the Hon'ble Executive Chairperson while the Secretary, District Legal Services Authority, East & North at Gangtok proposed the vote of thanks.

MENTAL HEALTH CAMP

Under the directions of the Hon'ble Executive Chairperson and in compliance to the resolution taken during the 19th All India Meet of State Legal Services Authorities held on 30th June to 1st July, 2023 at Srinagar, Jammu & Kashmir and under the NALSA (Legal Services to the Mentally III and Mentally Disabled Persons) Scheme, 2015; the Sikkim SLSA under the aegis of NALSA and in coordination with Sikkim Manipal University, Department of Psychiatry (SMIMS) organized Mental Health Camps at State Central Prison, Rongyek, Gangtok District on 13th June, 2025.

Similar camp was organized jointly by the District Legal Services Authority, Namchi and Taluk Legal Services Committees, Namchi, Jorethang and Yangang in coordination with the Health & Family Welfare Department, Government of Sikkim at District Prison, Boomtar, Namchi District on 13th June, 2025.

During these camps, the Convicts and Under Trial Prisoners suffering from mental health issues were examined. Also other Convicts and Under Trial Prisoners suffering from various mental issues were provided counseling by the Psychiatrists and Clinical Psychologists.

OBSERVANCE OF WORLD ELDER ABUSE AWARENESS DAY

As per the directions of Hon'ble Executive Chairperson, Sikkim SLSA, the Sikkim State Legal Services Authority, under the aegis of National Legal Services Authority observed World Elder Abuse Awareness Day under the NALSA (Legal Services to Senior Citizens) Scheme, 2016 on 15th June, 2025 at M G Marg, Gangtok.

The event was organized in collaboration with the Women, Child, Senior Citizen and Divyanjan Department, Finance Department (Pension Section) and Health & Family Welfare Department, Government of Sikkim with mobile ambulances.

In order to raise awareness about the abuse, neglect and exploitation faced by elderly persons and availability of free legal aid and services to such category of persons, legal aid stalls manned by Retainer Lawyer, Panel Advocates, Officers and staff members of Sikkim SLSA were set up along with stalls manned by the officers of the aforesaid departments to enable them to avail benefits granted by the Government. Pamphlets published by Sikkim SLSA in vernacular languages pertaining to the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (Frequently Asked Questions) were distributed.

Free Medical and Psychological Check-up was also conducted by the medical professionals deputed by the Health & Family Welfare Department, Government of Sikkim. A large turnout of elderly persons availed the benefits provided by the various departments, including medical services. Screening of senior citizens by the medical team was conducted and those identified with hypertension and diabetes were suggested to visit the Government Hospital for further medical follow-up. The Health & Family Welfare Department under Pradhan Mantri Jan Arogya Yojana (PMJAY) assisted senior citizens to obtain health cards, more than 30 (thirty) walking sticks, were provided to the elderly by the Women, Child, Senior Citizen and Divyanjan Department.

All matters related to free legal aid, entitlements and various enactments were apprised not only to the senior citizens but also to the tourists, passersby and local public visiting the legal aid stall.

Under the directions of the Hon'ble Executive Chairperson, Sikkim SLSA and under the aegis of NALSA, the Sikkim State Legal Services Authority organized an awareness programme on 26th June, 2025 to mark the occasion of the International Day Against Drug Abuse and Illicit Trafficking in collaboration with Serenity Home, Information, Research, and Treatment on Chemical Dependency, Burtuk at the State Central Prison, Rongyek, Gangtok.

The programme was conducted for the Convicts and Under Trial Prisoners lodged at State Central Prison, Rongyek under Sikkim Anti Drugs Act (SADA), 2006 and the Narcotic Drugs and Psychotropic Substances Act (NDPS), 1985 and their family members.

NATIONAL LOK ADALAT:

The Sikkim State Legal Services Authority under the aegis and directions of NALSA, duly supervised at the State level by Hon'ble Mrs Justice Meenakshi Madan Rai, Judge, High Court of Sikkim & Executive Chairperson, Sikkim SLSA, organized National Lok Adalat on 10th May, 2025 in all the districts and taluk Lok Adalat benches within the State of Sikkim.

Total of 56 cases were taken up by the various Lok Adalat Benches which included bank recovery cases, criminal compoundable cases, MACT matters, matrimonial matters, land acquisition matters and other civil matters. 32 cases were disposed as settled, wherein, a sum of ₹1,98,76,845/- (Rupees one crore ninety-eight lakhs seventy-six thousand eight hundred and fourth five) only was awarded to the aggrieved parties by way of settlement during the National Lok Adalat and 24 cases were disposed as unsettled.




