MEETING OF THE HIGH POWERED COMMITTEE

In pursuance to the Notification bearing No. 21/Home/2020 dated 30/03/2022 issued by the Home Department, Government of Sikkim in compliance to the Order dated 23/03/2020 passed by the Hon'ble Supreme Court of India in Suo Moto Writ Petition (Civil) No. 01 of 2020 in Re-Contagion of COVID-19 VIRUS in Prisons, a meeting of the High Powered Committee under the chairmanship of Hon'ble Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA/Chairman, High Powered Committee was held via Video-Conferencing on 17th August, 2022.

The following agenda items were discussed during the said meeting:

Agenda Item No. 1: Confirmation of the Minutes of the Meeting of the High Powered Committee held via Video Conference on 20th May, 2022.

Agenda Item No. 2: Decongestion of Jails.

- (a) To consider Convicts who have undergone their sentence or are entitled to remission/suspension/commutation of sentence under Sections 432 and 432A of the Code of Criminal Procedure, 1973 (for short, "Cr.P.C.") and Furlough in terms of the Sikkim Prison Manual;
- (b) To consider UTPs released on Bail by the Court, but unable to furnish sureties;
- (c) To consider release of UTPs booked under compoundable offences;
- (d) To consider release of UTPs covered under Sections 436 and 436A of the Cr.P.C.;
- (e) To consider release of UTPs who may be covered under Section 3 of the Probation of Offenders Act, 1958, namely accused of offence under Sections 379,

380,381,404,420 of the Indian Penal Code or alleged to be an offence not more than 2 years imprisonment;

- (f) To consider UTPs eligible to be released on bail under Section 167 of the Cr.P.C. and under Section 167(2)(a)(i) and (ii) of the Cr.P.C. read with Section 36A of the Narcotic Drugs and Psychotropic Substances Act, 1985 (where persons accused of Section 19 of Section 24 or Section 27A or for offences involving commercial quantity) where investigation is not completed in 60/90/180 days;
- (g) To consider release of UTPs who are imprisoned for offences which carry a maximum punishment of 2 years;
- (h) To consider release of vulnerable UTPs who are sick or infirm and require specialized medical treatment;
- (i) To consider release of UTPs who are women;
- (j) To consider the release of UTPs who are first time offenders between the ages 19 and 21 and in custody for offences punishable with less than 7 years of imprisonment and have suffered at least 1/4th of the maximum sentence prescribed;
- (k) To consider release of UTPs who are of unsound mind;
- (I) To consider UTPs eligible for release under Section 437(6) of the Cr.P.C., wherein in a case triable by a Magistrate, the trial of a person accused of any non-bailable offence has not been concluded within a period of 60 days from the first date fixed for taking evidence in the case:
- (m) To consider release of UTPs detained under Sections 107, 108, 109, 151 of the Cr.P.C.
- Agenda Item No. 3: UTPs and Convicts with COVID-19 in the State Central Prison, Rongyek, East Sikkim and District Prison, Boomtar, Namchi, South Sikkim and availability of medical facilities and treatment.
- Agenda Item No. 4: Continuation of sanitization and maintenance of hygiene and cleanliness in the State Central Prison, Rongyek, East Sikkim and District Prison, Boomtar, South Sikkim.
- Agenda Item No. 5: Number of new UTPs since 20.05.2022 and the latest vaccination position of UTPs, Convicts, Officers and staff at the State Central Prison, Rongyek, East Sikkim and District Prison, Boomtar, South Sikkim.
- Agenda Item No. 6: Present mode of production of UTPs before Courts and continuation of Video Conference for remand.

The Sikkim State Legal Services Authority organized a Sensitization Programme on Positive Mental Health for the officers and staff of Rural Development Department, Government of Sikkim in collaboration with the Department of Psychiatry, New Multispecialty Hospital, Sochakgang on 26th August, 2022 in the Auditorium of Sikkim Judicial Academy, Sokeythang, East Sikkim under NALSA (Legal Services to the Mentally III and Mentally Disabled Persons) Scheme, 2015.

Resource Persons Dr. C.L. Pradhan, Consultant and Ms. Nancy Palmu Chankapa, Senior Clinical Psychologist from the Department of Psychiatry, New Multispecialty Hospital, Sochakgang spoke on mental health issues, stress management and coping mechanisms.

82 officers and staff of Rural Development Department attended the programme.

The welcome address was delivered by Ms Subarna Rai, Member Secretary, Sikkim SLSA and the vote of thanks was proposed by Mr. Praveen Pradhan, Deputy Secretary, Sikkim SLSA.

MEGA LEGAL AWARENESS AND OUTREACH PROGRAMME

The Sikkim State Legal Services Authority under the directions of Hon'ble Executive Chairperson, Sikkim SLSA organized a Megal Legal Awareness and Outreach Programme in co-ordination with District Legal Services Authority, West District on (i) 24th September, 2022 at Government Senior Secondary School, Maneybong Block, Uttarey, Gyalshing District and on (ii) 25th September, 2022 at Dow Gyatso Kazi Senior Secondary School, Mangalbaria, Soreng District. NALSA (Legal Services for Differently Abled Children) Scheme, 2021 was launched at Uttarey, The programme also focused on NALSA (Legal Services to Victims of Trafficking and Commercial Sexual Exploitation) Scheme, 2015, NALSA (Legal Services to Senior Citizens) Scheme, 2016, NALSA (Child Friendly Legal Services and their Protection) Scheme, 2015, Protection of Children from Sexual Offences Act, 2012, Sikkim Anti Drugs Act, 2006.

The programme in both the places were presided over by the Chief Guest, Hon'ble Mr. Justice Biswanath Somadder, Chief Justice, High Court of Sikkim & Patron-in-Chief, Sikkim SLSA in the presence of Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim & Executive Chairperson, Sikkim SLSA as the 'Guest of Honour'.
