ACTIVITIES UNDERTAKEN BY SIKKIM SLSA UNDER THE PAN INDIA CAMPAIGN EMPOWERMENT OF CITIZENS THROUGH LEGAL AWARENESS AND OUTREACH AND HAQ_HUMARA_BHI_TO_HAI @ 75 W.E.F. 1st NOVEMBER TO 13th NOVEMBER, 2022

The National Legal Services Authority launched the Pan India campaign Empowerment of Citizens through Legal Awareness and Outreach and Haq_humara_bhi_to_hai @ 75 to bridge the gap between the institutions and the underprivileged by spreading legal awareness and ensuring delivery of legal entitlement to eligible beneficiaries.

As per the guidelines contained in the two campaigns and under the guidance of Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA, the following activities were undertaken by Sikkim SLSA and District Legal Services Authorities w.e.f. 1st November, 2022 to 13th of November, 2022:-

Sikkim State Legal Services Authority:

a) A legal awareness on Protection of Children from Sexual Offences Act, 2012, Juvenile Justice (Care & Protection of Children) Act, 2015 and Human Trafficking was organized by Sikkim SLSA for the students of Class IX and X and accompanying teachers of thirteen schools of Gangtok on 12th November, 2022 on the occasion of National Legal Services Week and Empowerment of Citizens through Legal Awareness and Outreach campaign.

Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA graced the programme as the Chief Guest. She enlightened the gathering on the stringent provisions of the Protection of Children from Sexual Offences

Act, 2012 and the various types of sexual assaults as defined under Sections 3,5 7 and 9 of the POCSO Act, 2012 and the long period of incarceration for the offences under this Act. The precautions which a male and female children should take so that such offences are not committed by them knowingly or unknowingly and how one ought to protect themselves from sexual assault was also discussed by her Ladyship. Further, emphasis on mental health and its importance in the evolving society was discussed along with the growing concern of substance abuse and the provisions of Sikkim Anti Drugs Act, 2006. The stringent bail provisions under both the POCSO Act and SADA were also highlighted.

Resource Person, Ms. Subarna Rai, Member Secretary, Sikkim SLSA gave a brief background on the Juvenile Justice (Care and Protection of Children) Act, 2015, its formation and various amendments and changes made in the Act. She informed all participants of the four Juvenile Justice Boards and Children's Courts established in Gangtok, Mangan, Namchi and Gyalshing and of the two operational Juvenile Observation Homes in Gangtok and Namchi. The roles of Child Welfare Officer, Special Juvenile Police Unit and Probation Officer were also explained to the students along with the difference between a child in conflict with law and a child in need of care and protection. The helpline number 1098 through which anyone could report any incidents concerning children was also disseminated.

Resource Person, Ms. Dhan Maya Subba, Superintendent of Police, Anti Human Trafficking Unit, Sikkim Police spoke at length on Human Trafficking, the modern slave system and the penal provisions contained in Section 370 of the Indian Penal Code, 1985 which deals

with trafficking of persons. She urged the school children not to ostracize victims of trafficking who may be in their class or in their schools. The Superintendent of Police, AHTU also informed that Anti Human Trafficking Clubs have been formed in various schools of Sikkim wherein students from Class IX and above are enrolled as its members.

The welcome address was delivered by Mrs. Matilda Isaacs, Consultant, Sikkim SLSA while the vote of thanks was proposed by Mr. Praveen Pradhan, Deputy Secretary, Sikkim SLSA. The programme concluded with queries raised by the students followed by vibrant interaction.

b) As part of the campaign, a visit was made to the Tintek Lee Aal Old Age Home at Tintek, Gangtok which houses 23 senior citizens (Male: 15 & Female: 08). During the visit, NALSA's theme song Sankalp song and a comedy short film titled "Sun ko Aunthi" was screened for the residents of the Home and refreshments were also provided to them.

c) Further, a visit-cum-inspection was made to Special School for Children with Disabilities, Gangtok, a Child Care Institution where there are 88 children (Boys: 56 and Girls: 32). The school was thoroughly inspected in terms of infrastructure and trained manpower. An interactive session was held with the children during the visit.

d) Under the campaign Haq_humara_bhi_to_hai@75 and on the occasion of National Legal Services Day, Legal Awareness Camp about rights and remedies available to prisoners was conducted by Sikkim SLSA in co-ordination with District Legal Services Authority, East District in the State Prison at Rongyek on 09th November, 2022. The programme was chaired by Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA and attended by 118 Convicts (Male: 117 & Female: 01) and 173 UTPs (Male: 171 & Female: 02).

Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA addressed the gathering on the provisions of the Sikkim Anti Drugs Act (SADA), 2006, the growing concern of substance abuse and steps taken by the Sikkim SLSA to help de-addiction and whole person recovery of incarcerated substance abusers by obtaining the voluntary services of NGOs running Rehabilitation Centres, to counsel them at the jail premises. The Mental Healthcare Act of 2017 and concerns of mental health of UTPs and convicts was also highlighted while steps taken by the Sikkim SLSA to mitigate the problem by ensuring that a Psychiatrist and Psychologists are on call for counselling was also emphasized. The Protection of Children from Sexual Offences Act, 2012 (POCSO Act, 2012) was discussed at length. The availability of free legal aid from the Sikkim SLSA from the stage of remand of accused persons, up to the various Appellate fora were also explained.

Resource Person, Mr. S.S. Hamal, Senior Advocate, High Court of Sikkim and Senior Panel Advocate, Sikkim SLSA apprised the participants on Sikkim Anti Drugs Act, 2006 (SADA), Mental Health Care Act of 2017, Protection of Children from Sexual Offences Act, 2012, Rights of the Arrested Persons, benefits of Plea Bargaining and free legal aid and services.

A short film named "Naya Mancheyy" produced by Sikkim SLSA concerning substance abuse was also released by Her Ladyship at the programme. The film has been uploaded in the official YouTube channel and Facebook page of Sikkim SLSA.

In depth Mental Health Counselling was provided to 26 convicts (Male: 25 & Female: 01) by Dr. C.L. Pradhan and Dr. Bibushan Dahal, Psychiatrists and Mrs. Nancy Palmu Chankapa and Ms. Archana Chettri, Clinical Psychologists from the New Multi Specialty Hospital in the Jail premises. Mental well being exercises were also demonstrated to all the inmates.

The welcome address was delivered by Ms. Subarna Rai, Member Secretary, Sikkim SLSA while the vote of thanks was proposed by Mr. Sherab Tonyot, Deputy Inspector General of Police (Prison), State Central Prison, Rongyek. The programme concluded with an active interaction and queries by the inmates.

The programme also had the presence of Mrs. K.C. Barphungpa, Principal District & Sessions Judge/Chairperson, District Legal Services Authority, Gangtok, Judicial Officers of Gangtok District, Mrs. Matilda Isaacs, Consultant, Sikkim SLSA, Prison Authorities, Officers and Staff of Sikkim SLSA and Press and Media.

TRAINING PROGRAMME ON PROTECTION OF CHILDREN FROM SEXUAL OFFENCES ACT, 2012 AND JUVENILE JUSTICE (CARE & PROTECTION OF CHILDREN) ACT, 2015

The Sikkim State Legal Services Authority organized a Training Programme on the proper and effective implementation of "Protection of Children from Sexual Offences (POCSO) Act, 2012 read with Protection of Children from Sexual Offences (POCSO) Rules, 2012 and Juvenile Justice (Care and Protection of Children) Act, 2015" for all stakeholders namely, Judges of the Special Courts under the POCSO Act, 2012, Designated Senior Advocate, High Court of Sikkim, Officers from Police Department, Women & Child Development Department, Medical Officers, Psychiatrists and Psychologists from the Health & Family Welfare Department, Public Prosecutors, Additional Public Prosecutors, Members of the Juvenile Justice Boards and Child Welfare Committees, Retainer Lawyers and Panel Advocates of Sikkim SLSA on 26th November, 2022 at Sikkim Judicial Academy, Sokeythang, East Sikkim.

Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA during her inaugural address highlighted the important provisions of the Juvenile Justice (Care and Protection of Children) Act 2015 and the POCSO Act, 2012 and various issues relating to child in conflict with law, child in need of care and protection, the role and responsibility of Members of District Child Protection Units, Special Juvenile Police Units, Counselors, Outreach Workers and the Courts. The importance of the 1st responder to the incident was explained at length. The purpose of 'Mission Vatsalya' of Ministry of Women and Child Development was also adverted to. A suggestion was put forth for the constitution of "Crisis Intervention Team" for child victims. The media were sounded on the provisions of Section 23 of the POCSO Act while reporting such offences and the bar on disclosing the identity of the victim.

Resource Person, Hon'ble Mr. Justice S.P. Wangdi, former Judge, High Court of Sikkim/Executive Chairman, Sikkim SLSA and the Chairperson, Police

Accountability Commission of Sikkim apprised the participants on "Juvenile Justice (Care and Protection of Children) Act, 2015" with a detailed historical background of the Juvenile Justice (Care and Protection of Children) Act, 2015, the present position of the law with emphasis on the landmark judgments passed by the Hon'ble Supreme Court which had paved the way for enactment of this beneficial legislation. He also stressed on the rehabilitative approach towards children.

Resource Person, Mrs. K.C. Barphungpa, Ld. Judge, Special Court (POCSO Act), Gangtok District & Chairperson, District Legal Services Authority, East dwelt at length on the provisions of Protection of Children from Sexual Offences Act, 2012 and the POCSO, Rules, 2012. The various provisions under the POCSO Act and its penal repercussions were also explained. The stakeholders were further sensitized on the manner of recording statements of the POCSO survivors.

Resource Person, Dr. Shaibya Saldanha, Obstetrician and Gynaecologist and Founder of Enfold, India spoke on Medical examination of POCSO survivors and on approach to Trauma Informed Care and Medical Examination and Collection of Forensic Evidence, Documentation and Writing a Medical Report. She elaborated on the method of medical examination that is to be adopted in cases of POCSO survivors and how doctors had to consider the matter with confidentiality and urgency.

Resource Person, Dr. Sonam O. Lassopa, Senior Clinical Psychologist, New STNM Multispecialty Hospital, Gangtok spoke on the topic "Dealing with trauma faced by POCSO survivors and their family members and an overview of their mental health". She discussed the trauma faced by POCSO survivors and coping mechanisms. The ways in which the first responders can help the children cope with several aspects of mental health were explained at length.

The sessions were followed by vibrant interactive discussions on queries raised by the participants addressed by the Chief Guest and the Resource Persons.

The welcome address was delivered by Ms. Subarna Rai, Member Secretary, Sikkim SLSA and the vote of thanks was proposed by Mr. Praveen Pradhan, Deputy Secretary, Sikkim SLSA.

The programme also had the participation of Director, Sikkim Judicial Academy, Registrar, High Court of Sikkim, Mrs. Matilda Isaacs, Consultant, Sikkim SLSA, Officers and staff of Sikkim SLSA and Press and Media.
