SENSITIZATION PROGRAMME ON SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013

Pursuant to the directions of the Hon'ble Supreme Court of India, in its Order dated 12th May, 2023 passed in Civil Appeal No 2482 of 2014 titled Aureliano Fernandes v State of Goa and Ors and under the directions of Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLISA, the Sikkim State Legal Services Authority organized a Sensitization Programme on Sexual Harassment of Women at Workplace (Prevention, Prohibition & Redressal) Act, 2013 for female employees and Members of Internal Complaints Committee of Police Department, Government of Sikkim on 28th October, 2024 at the Conference Hall of the Sikkim SLISA, Development Area, Gangtok.

Trained Panel Advocates Mr Sushant Subba, Mr Hem Lall Manger and Mr Passang Tshering Bhutia were the Resource Persons.

The topics discussed/covered were Background and Role of Internal Committee - Prevention, Prohibition and Redressal, Definition of Sexual Harassment, Procedures and Process for Redressal and Case Study Analysis.

During the course of the programme, a short movie titled "Ab Khamosh Kyun" produced by Human Rights Law Network, New Delhi was also screened.

The programme was attended by 51 officers and staff members of the Police Department.

MEETING OF THE HIGH - POWERED COMMITTEE

A meeting of the High Powered Committee under the chairmanship of Hon'ble Mrs Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA/Chairman, High Powered Committee was held on 11th December, 2024 via virtual mode.

The meeting was attended by Mr R Telang, IAS., the then Additional Chief Secretary, Home Department, Government of Sikkim/Member, High Powered

Committee, Mrs Samita Sharma, Member Secretary, Sikkim SLSA, Mr Thakur Thapa, Deputy Inspector General of Police with additional charge of State Central Prison, Rongyek, High Powered Committee, Mr Khem Bhattarai, Additional Secretary (Confidential) /Member, High Powered Committee, and Mr Tseten Palzor Bhutia, Additional Superintendent of Police, District Prison, Boomtar, Namchi/Member, High Powered Committee.

The following Agenda Items were deliberated during the meeting:

Agenda Item No. 1: Confirmation of the Minutes of the Meeting of the High Powered Committee which was held on 31st May, 2024.

Agenda Item No. 2: DECONGESTION OF JAILS.

- (a) To consider Convicts who have undergone their sentence or are entitled to remission/suspension/commutation of sentence under Sections 432 and 432A of the Code of Criminal Procedure, 1973 (for short, "Cr P C") and Furlough in terms of the Sikkim Prison Manual;
- (b) To consider UTPs released on Bail by the Court, but unable to furnish sureties;
- (c) To consider release of UTPs booked under compoundable offences;
- (d) To consider release of UTPs covered under Sections 436 and 436A of the Cr P C/Sections 478 and 479 of the BNSS;
- (e) To consider release of UTPs who may be covered under Section 3 of the Probation of Offenders Act, 1958, namely accused of offence under Sections 379, 380,381,404,420 of the Indian Penal Code, 1860 (for short "IPC")/Sections 303(2), 304, 305, 306, 315 and 318(4) of the Bharatiya Nyaya Sanhita, 203 (for short "BNS"), or alleged to be an offence not more than 2 years imprisonment;
- (f) To consider UTPs eligible to be released on bail under Section 167 of the Cr P C /Section 187 of the BNS and under Section 167(2)(a)(i) and (ii) of the Cr.P.C./Section 187(2)a(i) and (ii) of the BNS read with Section 36A of the Narcotic Drugs and Psychotropic Substances Act, 1985 (where persons accused of Section 19 of Section 24 or Section 27A or for offences involving commercial quantity) where investigation is not completed in 60/90/180 days;

- (g) To consider release of UTPs who are imprisoned for offences which carry a maximum punishment of 2 years;
- (h) To consider release of vulnerable UTPs who are sick or infirm and require specialized medical treatment;
- (i) To consider release of UTPs who are women;
- (j) To consider release of UTPs who are first time offenders between the ages 19 and 21 and in custody for offences punishable with less than 7 years of imprisonment and have suffered at least 1/4th of the maximum sentence prescribed;
- (k) To consider release of UTPs who are of unsound mind;
- (l) To consider UTPs eligible for release under Section 437(6) of the Cr P C/Section 480(6) of BNSS, wherein in a case triable by a Magistrate, the trial of a person accused of any non-bailable offence has not been concluded within a period of 60 days from the first date fixed for taking evidence in the case;
- (m) To consider release of UTPs detained under Sections 107, 108, 109, 151 of the Cr P C/Sections 126, 127, 128 and 170 of BNSS.

Agenda Item No. 3: UTPs and Convicts with COVID-19 in the State Central Prison, Rongyek, East Sikkim and District Prison, Boomtar, Namchi, South Sikkim and availability of medical facilities and treatment.

Agenda Item No. 4: Continuation of sanitization and maintenance of hygiene and cleanliness in the State Central Prison, Rongyek, East Sikkim and District Prison, Boomtar, Namchi South Sikkim.

MENTAL HEALTH CAMP

In compliance to the resolution taken during the 19th All India Meet of State Legal Services Authorities held on 30th June to 1st July, 2023 at Srinagar, Jammu & Kashmir, and under the NALSA (Legal Services to the Mentally Ill and Mentally Disabled Persons) Scheme, 2015, the Sikkim SLSA under the aegis of NALSA and in co-ordination with Sikkim Manipal Institute of Medical Sciences (Department of Psychiatry) organized Mental Health Camps at State Central Prison, Rongyek, Gangtok District on 13th December, 2024.

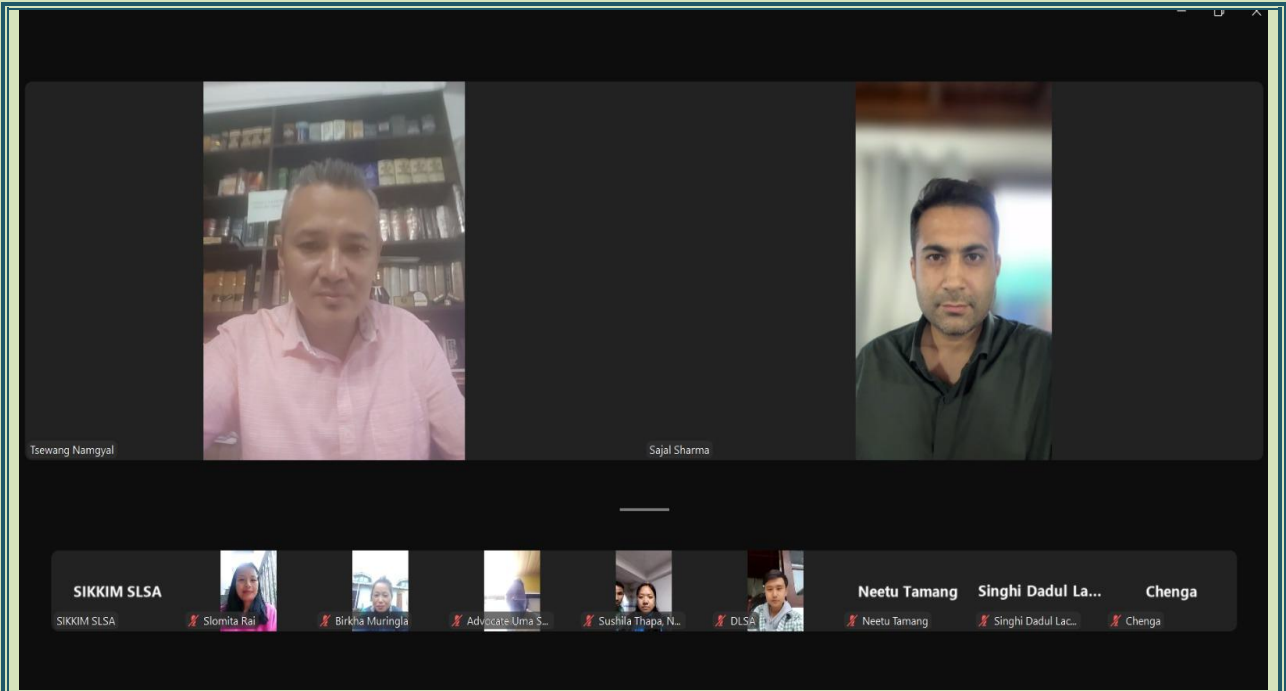

TRAINING PROGRAMMES FOR PANEL ADVOCATES

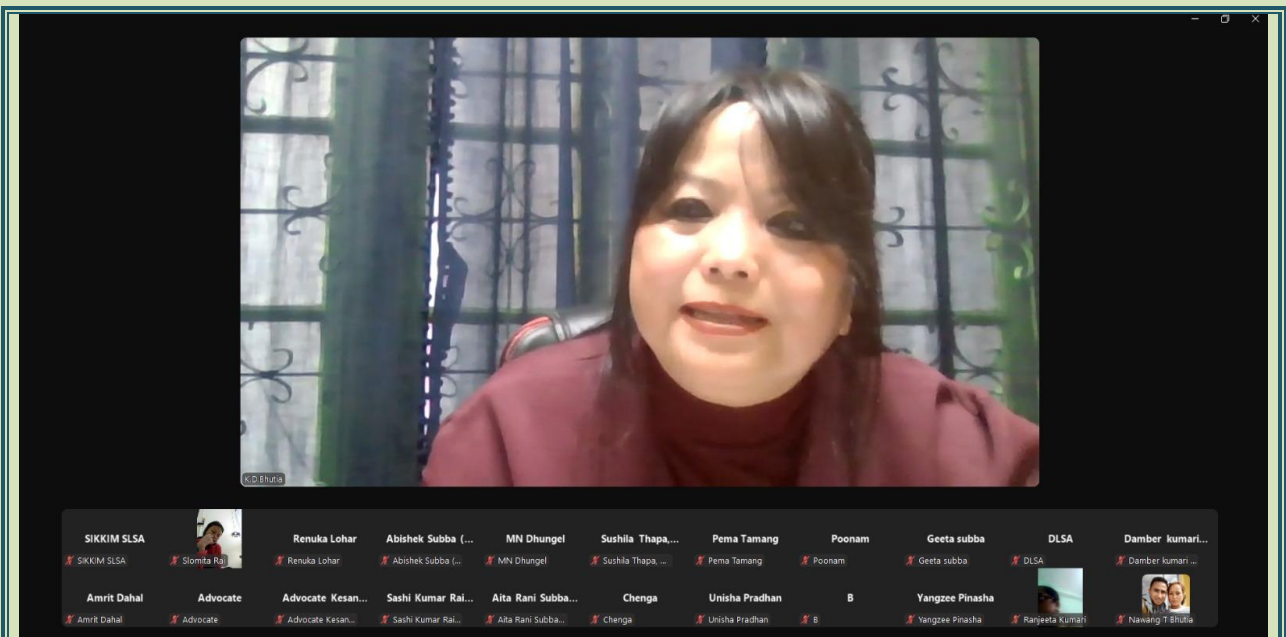

Three training programmes was conducted via virtual mode during the quarter October to December, 2024 which are as follows:

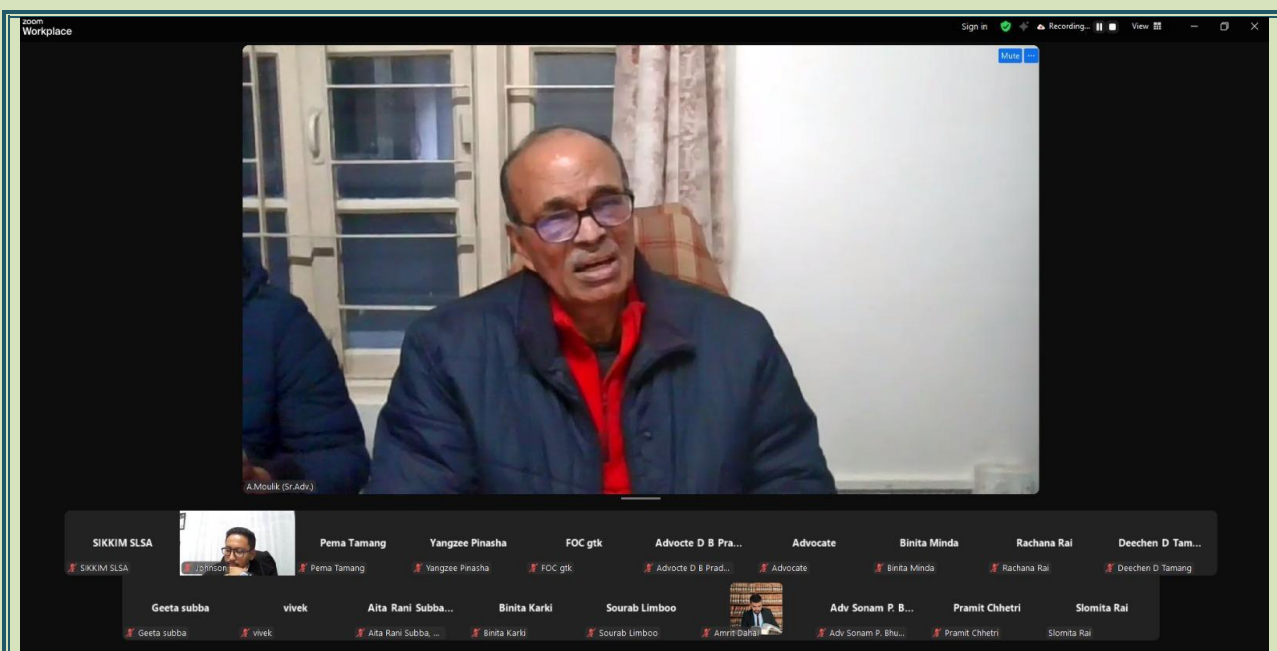
